COVID-19 Waiver and Release

In consideration for my attendance at the ASID Texas Chapter event, the receipt and sufficiency of which is hereby acknowledged, I hereby agree to the following.

- The Coronavirus/COVID-19 is highly contagious and dangerous and there is risk of contracting Coronavirus/COVID-19 if I attend the event.

- I, as well as all household members, have not knowingly been exposed to anyone diagnosed with Coronavirus/COVID-19 within the past 30 days.
- I, as well as all household members, have not traveled outside of the country or to any U.S. city or state considered to be a "hot spot" for Coronavirus/COVID-19 infections within the past 30 days.
- I am following all CDC recommended guidelines as much as possible and limiting my exposure to the Coronavirus/COVID-19 and
- I am following all applicable state and local rules and regulations related to Coronavirus/COVID-19.

Therefore, I hereby release and agree to hold the American Society of Interior Designers, Inc and ASID Texas Chapter, the host for the event, and their officers, directors, employees, and agents, harmless from, and waive on behalf of myself, my heirs, and any personal representatives any and all causes of action, claims, demands, damages, costs, judgements, expenses and compensation for damage or loss to myself and and/or property that may be caused by any negligence, act, or failure to act of the ASID Texas Chapter, or that may otherwise arise in any way in connection with my attendances at the event.

Furthermore, I understand that this waiver discharges the American Society of Interior Designers, Inc., and ASID Texas Chapter from any and all liability or claim that I, my heirs, or any personal representatives may have against the American Society of Interior Designers, Inc., and ASID Texas Chapter with respect to any bodily injury, illness, death, medical treatment, or property damage that may arise from, or in connection to, my attendance at the event.

I expressly waive any such claim for compensation or liability on the part of ASID Texas Chapter in the event of injury, illness, or medical expenses incurred by me.
